501 North 14th Avenue Greeley, CO 80631 SB22-131 was introduced as a measure to remove the pesticide pre-emption policy in Colorado. The goal of the measure was to allow cities, counties, and other governing entities to be able to write and enforce individual pesticide policies. CoAAA joined forces with the Coloradoans for Responsible Pesticide Application (CRPA) to oppose this terrible measure. With agricultural producers and pesticide applicators showing a united front in the CRPA coalition we were able to successfully oppose SB22-131.

The measure may have died in the 2022 legislative session, but we are anticipating seeing similar legislation attempted in the 2023 session or during the sunset of the Colorado Pesticide Applicator Act. Rest assured the CoAAA will remain vigilant and oppose any negative legislation presented in the future.
